Welcome to Primitive/Group Camping at Holts Landing State Park!

- **Capacity:** There are 3 designated campsites. A maximum of 40 people will be permitted in the Primitive Camping site at one time.
 - **Tent Camping Only:** Motor homes and trailers are not permitted. Tent camping is the only form of camping allowed in this area.
 - **Group Camping:** This area is intended for scouts, church groups, school clubs, etc. Traditional “family camping” is not permitted.
 - **Amenities:** In the Primitive area, you will find 2 (shared) ADA-accessible portable toilets. There are picnic tables and a fire rings scattered around the campsite. There are **no shower facilities** at this site. **CAMPERS SHOULD BRING THEIR OWN POTABLE WATER.**
 - **Trash & Recycling:** Holts Landing State Park is a “Carry-in, Carry-out” facility. It is up to the individual groups to dispose of any non-recyclables outside of the park. (There is a state park dumpster located near the maintenance shop near the main entrance the park.)
- Damages:** Groups are held responsible for any losses or damages to Park equipment and property.
- **Pets:** Dogs and pets are prohibited in the Primitive Camping area.
 - **Alcohol & Tobacco:** Alcoholic beverages and tobacco products are strictly prohibited in the Primitive Camping area.
 - **Firewood:** Effective immediately, all groups must purchase or use firewood from Sussex County Delaware. This will slow down the infestation of the emerald ash borer and other harmful insects. Fire rings are not to be moved under any circumstances. Fires must be supervised by an adult at all times and extinguished upon departure of the site. **BONFIRES ARE STRICTLY PROHIBITED.**

Thank you for your interest in camping at Holt's Landing State Park's primitive group sites. We have enclosed the Primitive Camping Application and a map of Holt's Landing State Park. Please be aware of the following:

1. A temporary reservation will be made only upon receipt of the camping application and the NON-Refundable deposit of \$20.00 for Delaware groups and \$40.00 for Out-of-State groups.
2. If the deposit is not received within 30 days of your arrival date, the reservation will be cancelled.
3. To secure your reservation, the per person/per night fee should be paid 10 days prior to your arrival date.
4. After your payment is processed you will be mailed/emailed/faxed the welcome information letter with additional information.
5. Please make sure you carefully read the information on the application and that the other group leaders are aware of the Park's rules and Regulations.
6. Parking passes will be mailed/emailed/faxed to you when your final payment is received.

I certify that I have read and understood the following Rules and Regulations:

Rates and Fees: A \$20.00 (for Delaware groups) or \$40.00 (for out-of-state groups) **non-refundable** application fee shall be submitted with this application. Please make checks payable to Holt's Landing State Park. Payments may be made over the phone by MasterCard and Visa. The Primitive Camping Fee is an additional \$3.00 per person per night, with a minimum of \$20 per night for DE Groups, and \$40 for out of State Groups.

1. Campers must bring their own drinking water.
2. Campers should bring insect repellent for tick, chigger and mosquito protection.
3. The Primitive Camping area is reserved for youth groups ages 18 and younger and does not include family groups.
4. Groups will be held responsible for any losses of damages to park equipment and property.
5. A maximum of 40 campers are permitted in the Primitive Camping area.
6. Dogs and other pets are prohibited in the Primitive Camping area.
7. Alcoholic beverages and tobacco are prohibited in the Primitive Camping area.
8. Tent camping is the only form of camping allowed in the Primitive Camping area. **Motor homes and trailers are not permitted.**
9. Each primitive group will be issued one car pass per five campers.
10. Vehicles must park in the designated Primitive Camping parking area. Parking on the grass is NOT ALLOWED.
11. Holt's Landing Day Use area is open 8 a.m. – sunset. Campers are advised to stay out of the day-use area after sunset.
12. Delaware State Parks operate with a Carry in – Carry out trash policy. Trash and/or litter in/around the primitive camping area will not be tolerated. Trash may be placed in the dumpster located in the maintenance area at Holt's Landing.
13. Nails and screws are not to be driven into trees for any reason. Campers may use downed limbs and trees for firewood. Chopping and sawing on standing trees whether alive or dead is strictly prohibited.
14. Fire rings are not to be moved under any circumstances. Fires must be supervised by an adult at all times and extinguished upon departure of the site. **BONFIRES ARE STRICTLY PROHIBITED.**
