Games may be scheduled March 15 - November 15, weather permitting.

Practices may begin no earlier than March 1, weather permitting. If the team is planning to use the fields for practice, check the box on page 3; dates are not required, and a special permit will be issued upon payment of the flat-rate practice fee.

Applications including the full year's schedule may be submitted and will be invoiced as below; applications received after the season cut-off will be reviewed on a first come, first served basis.

Spring season (March 15 - first weekend in June) cut-off: February 15 Summer season (second week in June through Labor Day) cut-off: May 1 Fall season (Labor Day through November 15) cut-off: August 15

#### **Practices**

- Payment of the flat rate fee for seasonal use of fields grants the permit holder the right to use the fields on a first come, first served basis for regular team practices.
- Priority field use is granted first to scheduled games and next to teams with a practice permit.
- If you opt not to pay the practice fee, you will be able to use the fields for practices provided no one else is using the field. You will be asked to leave the field if a team with a permit arrives to use the space while you are there.

#### **Permit Conditions**

- Team must have permit available for inspection when participating on park property.
- Participants shall follow all state park rules and regulations.
- In case of emergency, call 911. For all other calls between 8 am and 4 pm, contact the Park Office at 302-577-1164. After 4 pm, call 844-DEPARKS.

- Park areas open at 8 am and close at sunset.
- Alcoholic beverages are prohibited.
- Vending is not permitted in Wilmington State Parks without written authorization from the park office.
- No advertising, tents, trailers, or canopies may be posted or located without written authorization.
- No balloons or confetti are permitted.
- Exceeding end times will result in charges for an additional 2.5-hour reservation at the discretion of the Division.
- Damage to the fields, equipment, or facilities will result in a \$150 fine plus repair costs and may be grounds to cancel future reservations.

#### **Cancellation Policy**

- The Park Superintendent or authorized agent may terminate or change, with prior notice, the activity and/or its location, and assign Park Rangers to the Event, if necessary for the safety of the public, for the protection of the resources, or for the violation of any rules or regulations of the Division which you have notified Permittee or conditions of this Permit (subject to a period for Permittee to cure such violation). In addition, any event may be canceled with prior notice in the event of a natural disaster or unforeseen emergency. If Delaware State Parks cancels an event due to any of the above reasons, no refund or reschedule of the event is guaranteed. If there is an interruption to an event due to unforeseeable conditions, the event will be allowed to proceed past scheduled end time by the amount of time of interruption.
- There will be no refunds once the invoice is paid.

#### **Terms and Agreements**

- The Team/Organization agrees that it will indemnify and otherwise hold harmless the State of Delaware, its agents and employees from any and all liability, suits, actions, or claims, together with all costs, expenses for attorney's fees, arising out of PERMITTEE's its agents and employees' performance work or services in connection with the Agreement, regardless of whether such suits, actions, claims or liabilities are based upon acts or failures to act attributable, in whole or part, to the State, its employees or agents.
- Rules and regulations of the Division of Park and Recreation unless specifically exempted or
  otherwise noted shall be observed by the permittee, employees, agents or contractors. It is the
  responsibility of the event organizer to inform participants of applicable rules, regulations and
  terms of this agreement.
- I have read and understand the attached permit conditions. I agree to abide by all permit conditions and the rules and regulations of the Division of Parks and Recreation. I understand that any violation of state park rules and regulations under Title 7 Chapter 47 of the Delaware Code may result in the revocation or suspension of this permit. I agree to inform participants of the terms of this agreement.
